In the future, we may update our services to store additional information about users and their use of the App. This may include storing encrypted data on our servers. We will update this privacy policy to reflect any changes to our data storage practices.

2. Children's Privacy

We understand the importance of protecting children's privacy. Our App is designed to be safe for all ages, including under 13s. We do not knowingly collect personal data from children. Users are required to verify their age by checking a box when first using the app.

3. Third-Party Services and Imported Libraries

Our App uses third-party services and libraries, such as Mapbox, what3words, and other code libraries, to provide certain features. These third-party services may have access to your location data, which is used anonymously to provide mapping and location services within our App. They may collect, store, and use data in accordance with their own privacy policies.
